### How to reach the Conference Venue

#### From Termini Central Rail Station

- *Taxi*: take a taxi outside the station. The journey takes approx. 10 mins and the fare is around 15 Euros.
- *Public transport*: Outside the station, go to the TERMINI stop (MA-MB-FS) and take:
  - bus 90 (LABIA), (every 8 mins, journey lasts approx 15 mins). Alight after 5 stops at the stop NOMENTANA/VILLA TORLONIA, in via Nomentana and then walk for 150metres to the Conference Venue.
  - bus 82 (val d'aosta/staz.ne nomentana), (every 12 mins, journey lasts approx 15 mins). Alight after 7 stops at the stop NOMENTANA/VILLA TORLONIA, in via Nomentana and then walk for 150metres to the Conference Venue.

#### From Fiumicino Airport

- *Taxi*: take a taxi outside the airport. The journey takes approx. 45-50 mins and the fare is around 50-80 Euros, depending on traffic conditions.
- *Public transportation*: take the Leonardo Express train (every 30 mins, journey lasts approx. 30 mins, no intermediate stops, tickets 14 Euros) to Termini Central Rail Station, then follow the instructions as per from Termini Station above.

#### From Ciampino Airport

- *Taxi*: take a taxi outside the airport. The journey takes approx. 45-50 mins and the fare is around 50-80 Euros, depending on traffic conditions.
- *Public transportation*: Take the [Terravision Bus](#) outside the terminal to Termini Central Rail Station (every 20 mins, journey lasts approx. 40 mins, ticket 4 Euros), then follow the instructions as per from Termini Station above.
